3. We have heard learned counsels for the parties.

Having regard to the period of custody suffered by the accused-appellant i.e. about 15 years and the time that is likely to be taken for disposal of the appeal by the Allahabad High Court and also on account of the fact that the co-accused (Ram Rahish) has been released on bail by Order of this Court dated 30.11.2015, we are of the view that the present accused-appellant (Bharat Singh) shall also be released on bail. Accordingly, we direct that the accused-appellant be released

on bail in connection with F.I.R. No.143/94 dated 27.08.1994 to the satisfaction of the learned Additional District and Sessions Judge, Farrukhabad, U.P. in Session Trial No.324 of 1995.

5. The learned trial Court is free to impose all such conditions as it may deem fit.

6. The order of the High Court is set aside and the appeal is allowed.
