UPON hearing the counsel the Court made the following
O R D E R

- 1 During the course of the hearing, the Court has been apprised of the fact that the charge-sheet has been submitted before the competent court in May 2021.

- 2 In the above backdrop, Ms Bansuri Swaraj, counsel appearing on behalf of the State of Uttar Pradesh, states, on the instructions of the investigating officer, that since the charge-sheet has been duly filed after investigation was complete, custodial interrogation is not necessary, but, the petitioners must cooperate in the course of the trial.
- 3 We are not inclined to interfere with the order of the High Court declining to entertain the petition for quashing under Section 482 of the Code of Criminal Procedure 1973. However, we direct that the petitioners shall be admitted to bail, subject to such terms and conditions as may be fixed by the trial Judge, pending the trial. The petitioners shall cooperate in the expeditious disposal of the trial.
- 4 Subject to the above direction, the Special Leave Petition is disposed of.
- 5 Pending application, if any, stands disposed of.
