I.A. No. 114551/2023 - Amendment of Plaintiff

1. The present application is for amendment of the plaintiff in Original Suit No.6/2020, at the instance of the plaintiff-State of

Rajasthan.

2. Having heard Ms. Nidhi Jaswal, learned counsel appearing for the plaintiff and Mr. Jagjit Singh Chhabra, learned counsel appearing for the defendant no.1- State of Punjab, we allow amendment of the plaint in the following terms:

“(a) Paragraph 47A is permitted to be inserted between paragraphs 47 and 48 of the plaint; and

(b) The figures 8.60 MAF appearing in prayers (a) and (b) of the plaint shall be corrected to read as 0.60 MAF.”

3. Let amendments be carried out within four weeks and amended plaint be filed.

4. Amended written statement(s) may be filed within four weeks thereafter.
