O R D E R

The petitioners before this Court are seeking pre-arrest bail, which was declined by the High Court by order(s) dated 31.08.2020 and 03.09.2020.

It is informed that the chargesheet has been filed on 25.09.2019 under Section 299 of the Code of Criminal Procedure.

After having heard learned counsel for the parties and taking into consideration the material on record and without expressing any opinion on merits/demerits of the case, we find that the petitioners have made out a case of pre-arrest bail. Ordered accordingly.

In the event of arrest of the petitioners, namely, Rajendra Pandey and Suman Pandey (in SLP (CrI.) No. 4466 of 2020); Neha Shukla (in SLP (CrI.) No. 4461 of 2020; Anil Pandey and Manju @Amita Pandey (in SLP (CrI.) No. 5341 of 2020) in connection with Crime No. 151 of 2020 registered at Police Station Vijay Nagar, District Jabalpur, Madhya Pradesh, they shall be released on bail on furnishing bail bonds of Rs. 25000/- each with two sureties of

the like amount to the satisfaction of the arresting officer/trial court.

In view of above, the Special leave Petitions are disposed of.
