The prayer is for transfer of the Divorce Petition No.13 of 2019 filed under Section 12 of the Hindu Marriage Act, 1955, titled as "*Ashok Arya vs. Shivali Chauhan*", pending before Judge, Family Court at Jhansi (U.P.) to the Family Court, Sirmour, Himachal Pradesh.
