This writ petition is filed by the petitioner who is from Nepal seeking admission to Post Graduate medical course in the 3rd Respondent-University in one of the seats earmarked for foreign nationals. The complaint of the writ petitioner is that there is no response to the representation preferred by her. Though, the last date for admission has expired on 31.08.2020, there are still vacant seats earmarked for foreign nationals in the 3rd Respondent-University and that she is entitled for admission.

Mr. Vikramjit Banerjee, learned Additional Solicitor General submitted that there is a procedure for foreign nationals to make application for allotment of seats reserved for them in medical courses in India. The application has to be filed before the Indian Embassy in a foreign country which

is then forwarded to the Ministry of External Affairs and then processed. He stated that the petitioner has made application to the Ministry of External Affairs, Government of Nepal. Be that as it may, we are not inclined to entertain this writ petition, as a statement has been made by Mr. T.V. George, learned counsel appearing for the 3rd Respondent-University that there are no seats earmarked for foreign nationals for the past two academic years. He further submitted that all the seats for Post Graduate medical courses in the 3rd Respondent-University have been filled up and there is no vacancy available for the petitioner.

Writ Petition is dismissed. Pending application(s), if any, shall also stand disposed of.
