Mr. K.M. Natraj, learned Additional Solicitor General, on instructions, submits that the plea taken by

the petitioner regarding precarious health condition is doubtful.

According to the information available to the concerned authorities, the petitioner is freely moving around in the area and also travelling elsewhere.

To put quietus to this difference of opinion, we direct the petitioner to undergo medical checkup at AIIMS, New Delhi within one week from today.

We request the Director, AIIMS, New Delhi to make necessary arrangements for medical checkup of the petitioner and submit the report in sealed cover before the next date of hearing. The petitioner shall appear before the Director, AIIMS, New Delhi on 01.10.2021 at 11:00 a.m.

List this matter on 04.10.2021.

In the meantime, no precipitative steps be taken against the petitioner, provided he extends full cooperation to the Investigating Officer in respect of subject matter.

We are inclined to show this indulgence in view of order dated 22.07.2020 passed in SLP (Cr1.) No. 2895 of 2020 in the case of this petition.
