Heard Ms. Jaikriti S. Jadeja, learned counsel appearing for the petitioner (wife) and Mr. Ravindra Adsure, learned counsel appearing for the respondent (husband).

The respondent has not filed counter affidavit. However, learned counsel for the respondent submits that the matter need not be transferred and mediation should be attempted.

Taking note of the averments in the transfer petition and the fact that various other proceedings against the respondent are pending before the Court at Amreli, Gujarat, we deem it appropriate to order for transfer of M.J. No. A-1025 of 2020 titled as *Umang Satish Popat alias Thakkar v. Alpa Umang Thakkar & Anr.* pending before Family Court, Bandra at Mumbai to the Court of Principal Civil Judge, at Dhari, Dist. Amreli, Gujarat.

Registry to communicate a copy of this order to the transferor Court for transferring the record of the case to

the transferee Court forthwith.

The transfer petition is allowed accordingly.

However, keeping in mind the submission of the counsel for the parties, the transferee Court should facilitate Mediation between the petitioner and the respondent, before proceeding to adjudicate the case on merit.
