We have heard Mr. P.S. Patwalia and Mr. R. Basant, learned Senior Advocates appearing on behalf of the respective petitioners, Mr. Sudhanshu S. Choudhari, learned counsel appearing for the informant and Mr. Rahul Chitnis, learned counsel appearing for the respondent-State of Maharashtra at length.
