**ORDER**

- 1 This transfer petition has been filed by the petitioner-wife for transfer of Case No CO 368/2020 titled “Naynesh Sharma Vs Khushboo @ Khushboo Sharma” from the Family Court No 1, Jodhpur, Rajasthan to competent court of jurisdiction at Hyderabad, Telangana.
- 2 We have heard learned counsel for the parties.
- 3 Having regard to the interests of justice, we are of the view that an order for the transfer of the proceedings is warranted. We accordingly allow the transfer petition and direct that Case No CO 368/2020 titled “Naynesh Sharma Vs Khushboo @ Khushboo Sharma” be transferred from the Family Court No 1, Jodhpur, Rajasthan to the District Judge at Hyderabad, Telangana who shall assign the case to the court of competent jurisdiction at Hyderabad, Telangana.
- 4 The transferor court shall forthwith transmit the record of the aforesaid case to the transferee court.

- 5 Counsel appearing for the contesting parties state that the parties shall explore the possibility of an amicable resolution of the matrimonial dispute by appearing before the Mediation Centre attached to the transferee Court on the date to be fixed by the transferee Court. The parties would be at liberty to make a request before the Mediation Centre for participating in the proceedings through video conferencing.
- 6 Pending application, if any, stands disposed of.
