Heard learned counsel for the parties and perused the affidavit filed by the appellant in pursuance to our last order which sets out the list of assets both movable and immovable.

We are of the view that since the appellant has the option of giving security of immovable property, albeit the impugned directions containing it for Rs.2 crores and these assets being valued at less than that amount as per circle rate, it would be appropriate to direct the appellant to give security of all the three immovable properties subject of course to the charge on the first property of a loan of Rs.5 lakhs taken under the Kisan Credit Card Scheme.

To this extent the impugned orders stand modified.

The appeals stand disposed of.

The needful be done by the appellant by furnishing the original title deeds for verification and the same be filed within two weeks before the trial Court.
