The petitioner (wife) seeks transfer of Original Suit No.20 of 2019 titled as "Deepak Singh Vs Rinki Singh" filed by the respondent (husband) for restitution of conjugal rights which is pending in the Court of Principal Judge, Family Court, West Singhbhum at Chaibasa, Jharkhand to a Court of competent jurisdiction at Bhillai, Chhattisgarh.

The marriage between the parties was solemnized on 27-12-2016 and a girl child born out of the wedlock is in the custody of the petitioner.

The petitioner (wife) on account of some matrimonial discord is presently staying with her parents.

The respondent (husband) has filed the above-stated petition for restitution of conjugal rights at a place which is 650 kms. away from the place of residence of the petitioner (wife). She apprehends physical harm in the event of her going to West Singhbhum at Chaibasa, Jharkhand to defend herself in the afore-stated case.

Since the plea taken by the petitioner has not been controverted by the respondent (husband), who has failed to put in appearance despite service of notice, the instant Transfer Petition is allowed. The Original Suit No.20 of 2019 titled as "Deepak Singh Vs Rinki Singh" filed by the respondent (husband) for restitution of conjugal rights is ordered to be transferred from the Court of Principal Judge, Family Court, West Singhbhum at Chaibasa, Jharkhand to a Court of competent jurisdiction at Bhillai, Chhattisgarh.

The records be forwarded to the transferee Court forthwith.
