ORDER

- 1 This transfer petition has been filed by the petitioner-wife for transfer of the proceedings in HMA No 323 of 2020 titled “Joginder Singh vs Manesh Kumari” from the Court of the Principal Judge, Family Court, Jind, Haryana to the Court of the Principal Judge, Family Court, Patiala House Courts, New Delhi .
- 2 We have heard counsel appearing on behalf of the parties.
- 3 Having regard to the interests of justice, we are of the view that an order for the transfer of the proceedings is warranted. We accordingly allow the transfer petition and direct that the proceedings in HMA No 323 of 2020 titled “Joginder Singh vs Manesh Kumari” be transferred from the Court of the Principal Judge, Family Court, Jind, Haryana to the Court of the Principal Judge, Family Court, Patiala House Courts, New Delhi .
- 4 The transferor court shall forthwith transmit the record of the aforesaid case to the transferee court.

- 5 After transfer of the petition, the transferee Court is directed to make all endeavour either for amicable settlement or for early decision in the matter without unnecessary adjournments.
- 6 Pending application(s), if any, stands disposed of.
