Delay of 96 days in preferring Review Petition is condoned.

Application for seeking direction for hearing the Review Petition in open Court is rejected.

The plea as regards adverse possession taken by the Review Petitioner was dealt with by the High Court as under:-

"14. ... ..In the present case, the plaintiff's case before the trial court was only that earlier his father was in possession over the suit land and after his death, they are now in possession. The defendant No.1 is real brother of plaintiffs and who was adopted by one Gopal Ji. The ownership of defendant No.1, when he was minor, the name of his father was recorded in Column No.12 *Khasra Panchshala* but he has never permitted the plaintiffs to use their suit land and plaintiffs have not filed any document to show that they have ever denied the title of plaintiff. ... .."

The Special Leave Petition arising therefrom was dismissed by this Court while affirming the view taken by the

**High Court.**

**We have gone through the grounds raised by the Petitioner in Review Petition and do not find any error apparent on record to justify interference in Review Jurisdiction.**

**This Review Petition is dismissed.**
