Petition as we find that the High Court has proceeded to dispose of the Writ Petition essentially on the finding noted in paragraphs 12 and 13 of the impugned judgment that the work on the subject plot was for development/beautification of the pond area, including road widening and nothing more.

As and when, any authority or party decides, proposes or attempts to change the use of the plot in question for any other activity which is not permissible in law, it will be open to the petitioners to approach the competent authority to assuage their grievance and for necessary relief(s), as may be advised.

We keep all contentions in that behalf open, to be decided in appropriate proceedings, if and when occasion arises.

The Special Leave Petition is disposed of accordingly.
