UPON hearing the counsel the Court made the following
O R D E R

In all the matters numbered above, all the appearing respondents are granted four weeks time, as last chance to file the counter affidavit, if not already filed.

Two weeks time, is granted to Id. Counsel for the petitioner, to take fresh steps and file fresh particulars, to issue notice to all the unserved respondents.

Despite service of notice on remaining respondents, there is no appearance on their behalf.

Ms. Aparna Bhatt, Id. Counsel has filed Vakalatnama on behalf of Respondent No. 47.3 in SLP(C) No. 3943/21, however as per petition there is only two Lrs. of Respondent No. 47 i.e. 47.1 & 47.2. Id. Counsel to clarify the same within a period of two weeks.

Id. Counsel submits that she will be filing vakalatnama on behalf of Respondent Nos. 24.3, 36, 9, 55-58 in SLP(C) No. 3943/2021 and for Respondent Nos. 36.1, 42 and 24 in SLP(C) No. 3969/2021.

Id. Counsel seeks and is granted one week's time to file the vakalatnama and counter affidavit.

Id. Counsel further submits that two of the parties who were parties before the High Court are not made parties before this Court. Id. Counsel shall provide the details and take appropriate steps in this regard.
