**UPON hearing the counsel the Court made the following
O R D E R**

1. Learned counsel for the petitioner states that there is no logistic issue as per the Office Report and the compliance has been made. The office report dated 22.09.2025 indicates as

under :

"It is submitted that vide order dated 25.04.2025 passed by the Hon'ble Judge-in-Chambers, the I. A. Nos. 189805/2024 and 190239/2024 are allowed for deletion of respondent Nos. 24.2 and 24.2 and 55.2 and 55.3, respectively, whereas the applications were filed for deletion of respondent Nos. 24.3 and 55.1 as R. Nos. 24.3 & 55.1 have expired and their Lrs. are already on record as R. Nos. 24.1 , 24.2 and 55.2 , 55.3, respectively. Hence, the names of R. Nos. 24.3 and 55.1 are proposed to be deleted as per Application Nos. 189805 of 2024 and 190239 of 2024 from the memo of parties and the cause title may be amended accordingly, hence Amended Cause Title is pending."

2. However, it would be in fitness of things to bring the office report into the knowledge of the Hon'ble Judge in Chamber, who may pass appropriate orders thereon.

3. On account of disposition of learned senior counsel Mr. J.P. Cama, time is sought for. Petitioners may seek instructions on IA No. 189761 of 2024 and clear the logistic issue, if any, surviving.

4. Let the matter be placed before the Hon'ble Judge-in-Chamber with detailed office report explaining the exact service position of the matters.
