O R D E R

This is a petition seeking transfer of HMA No. 1500/2019 titled as *Kailash Chauhan v. Meenakshi Jha* pending in the Court of District Judge, Family Court, Faridabad to a Court of like jurisdiction at Kanpur Nagar, U.P.

Heard Mr. Praveen Swarup, learned counsel for the petitioner (wife). Also heard Mr. Shrey Patnaik, learned counsel for the respondent (husband).

The parties are also participating in these proceedings through the virtual mode.

No issues are born from this marital relationship.

The attention of the Court is drawn towards the settlement arrived at by the parties through the efforts of Mediator appointed by the Supreme Court Mediation Centre and the terms are reflected in the settlement agreement dated 10.05.2022.

The Court is informed that the financial obligation as per the agreement have already been discharged by the

respondent towards the petitioner. By virtue of this settlement, the cases referred to in the settlement agreement i.e., (i) Complaint case No. 3331/2017 and (ii) Complaint Case No. 6456/2017 are ordered to be quashed and the cases at (iii) Review Petition No. 21074/2017, (iv) HMA/1500/2019 and (v) Suit No. CS/165/2021 are ordered to be closed.

Considering the above circumstances, invoking powers under Article 142 of the Constitution of India, the marriage between Meenakshi Jha and Kailash Chauhan is ordered to be dissolved.

Decree be drawn up in the above terms.

The parties are ordered to abide by the terms of the above settlement. Copy of the settlement agreement (10.05.2022) is made part of this order.

The transfer petition stands disposed of accordingly.
