**ORDER**

This transfer petition has been filed by the petitioner – wife for transfer of Marriage Petition No.F.C.O.P. No.1270/2018 titled “Mr. Mukesh K. Abichandani Vs. Mrs. Pooja M. Abichandani & Anr.” from the Court of the Additional Family Court Judge, City Civil Court, Hyderabad, Andhra Pradesh to the Family Court, Jaipur, Rajasathan.

No one appears on behalf of contesting Respondent No.1 despite valid service of notice.

Looking to the facts and circumstances of this case, particularly the fact that the petitioner has two minor daughters and, being a resident of Jaipur, Rajasthan, she would be put to considerable inconvenience in prosecuting the matter at Hyderabad, Andhra Pradesh, we think it appropriate to transfer the aforesaid case from the Court of the Additional Family Court Judge, City Civil Court, Hyderabad, Andhra Pradesh to the Family Court, Jaipur, Rajasathan.

Accordingly, the transfer petition is allowed.

The transferor court shall forthwith transmit the record of the aforesaid case to the transferee court.

After transfer of the petition, the transferee Court is directed to make all endeavour either for amicable settlement or for early decision in the matter without unnecessary adjournments.
