This transfer petition has been filed by the petitioner-wife under Section 25 of the Code of Civil Procedure, 1908 seeking transfer of Case No.524 of 2019 titled as "Shailabh Rastogi vs. Prerna Rastogi", pending before the Principal Judge, Family Court, Badaun, Uttar Pradesh to the Presiding Officer, Family Court, Gwalior, Madhya Pradesh.

Office report indicates that though the service of notice is complete, but the respondent-husband has not entered appearance so far.

Having considered the circumstances in their totality, we are of the view that in the interest of justice, transfer of the proceedings, as prayed for, is warranted.

The records of the case be transferred to the transferee Court forthwith.
