O R D E R

On 25.02.2021, a direction was given to the Admission and Fee Regulatory Committee to re-consider the proposals of the private self financing medical colleges for fee fixation from 2017-2018 onwards. The exercise was directed to be completed within a period of three months from that date. The Admission and Fee Regulatory Committee for Medical Education in Kerala has filed this application seeking extension of time for finalizing the fixation of fee as directed by this Court on 25.02.2021.

The direction issued on 25.02.2021 could not be complied with in view of the non-cooperation of the managements of medical colleges who have not furnished additional information/documents. In addition, the Covid-19 has also been the reason for the task not being completed within the stipulated time.

In the facts and circumstances of this case, we grant four weeks' time from today to complete the exercise. No further extension of time shall be granted.
