O R D E R

1. The present petition has been filed by the petitioner-wife seeking transfer of PA No.661 of 2020 filed by the respondent-husband titled "*Dhruv Tanwar v. Aarti Dhruv Tanwar*", pending before the Family Court No.4, Pune at Pune, Maharashtra to the Principal District Judge, Family Court, Gurugram at Haryana.

2. Having heard the learned counsel for the parties, we are of the opinion that interest of justice requires that the petition should be allowed.

3. Accordingly, PA No.661 of 2020 filed by the respondent-husband titled "*Dhruv Tanwar v. Aarti Dhruv Tanwar*", pending before the Family Court No.4, Pune at Pune, Maharashtra is ordered to be transferred to the Principal District Judge, Family Court, Gurugram at Haryana for hearing and disposal in accordance with law.

4. Records shall be sent by Court where proceedings are pending to the transferee Court promptly.
5. The transfer petition is, accordingly allowed.
6. On receipt of the case records, the transferee Court shall explore the possibility of a mediated settlement between the parties before proceeding with the merits of the matter.
