UPON hearing the counsel the Court made the following  
O R D E R

- 1 Mr Manish Kumar, counsel appearing on behalf of the petitioner submits that the petitioner is an existing institution which is conducting a five year full time Bachelor of Architecture degree course. The Council of Architecture

constituted under the Architects Act 1972 granted an extension of approval to the petitioner for imparting the five year full time course on 7 September 2021. The extension of affiliation by the Dr APJ Abdul Kalam Technical University, Lucknow (AKTU) is yet to be granted.

- 2 Counsel for the petitioner submits that the last date for counselling is 18 October 2021 and since the petitioner is an existing institution, the Court may follow its earlier orders by granting an extension of time. In this context, reference has been made to the previous orders of this Court dated 8 December 2020 in Writ Petition (Civil) No 1260 of 2020 (Annexure P-6) and 9 September 2021 in Writ Petition (Civil) No 875 of 2021 (Annexure P-26).
- 3 Issue notice, returnable on 8 October 2021.
- 4 Dasti, in addition, is permitted.
- 5 In addition, liberty is granted to serve the Standing Counsel, if any, for the respondents.
- 6 List the Petition on 8 October 2021.
