O R D E R

IA NO. 246581/2023 (FOR SUSPENSION OF SENTENCE)

This is an application for suspension of sentence of the

appellant pending the final disposal of this Appeal against conviction.

On 29th October, 2021, the prayer made by the appellant for suspension of sentence was rejected. In 2022, the application for the same relief was not pressed by the appellant. Now, the appellant has undergone actual incarceration for a period of 10 years and 06 months. The antecedents of the appellant have not been brought on record. The Appeal is not likely to be heard in near future. Therefore, the appellant is entitled to the relief of suspension of sentence and grant of bail.

For that purpose, we direct that the appellant shall be produced before the Trial Court within a period of one week from today. The Trial Court shall enlarge the appellant on bail on appropriate terms and conditions, till the final disposal of this Appeal.

Accordingly, IA No. 246581/2023 stands allowed.
