The petitions have been filed under Section 25 of C.P.C, 1908 seeking transfer of the matrimonial proceedings filed by the respondent under Section 13 of the Hindu Marriage Act, 1955 being HMA No.51/2020 titled "*Anuj Khanna vs. Moulshree Khanna*" pending before the Court of Family Judge, Gurugram, Haryana to the Family Court at Tis Hazari, New Delhi, and transfer of matrimonial proceedings filed by the respondent under Section 7 of the Guardianship and Wards Act, 1890 being Guardianship Petition No.12/2020 titled as "*Anuj Khanna vs. Moulshree Khanna*" pending before the Principal District Judge, Family Courts, Gurugram, Haryana to Family Court at Tis Hazari, New Delhi.
