With the consent of parties, we appoint Hon'ble Mr. Justice S.N.Variava, former Judge of this Court, to be the sole Arbitrator, to decide all disputes between the parties to the agreement. All questions will remain open to both sides, including as to whether the confirming party can be said to be a party to all the agreement.
