O R D E R

On perusal of the office report dated 25.03.2022, it is noted that notice was issued to the respondent by this Court on 16.11.2020 and the respondent was served on 02.12.2020 but no one has entered appearance on his behalf. In the circumstances, learned counsel for the petitioner only has been heard.

Learned counsel for the petitioner submitted that this transfer petition has been filed under Section 25 of the Code of Civil Procedure, 1908 seeking transfer of Case No. H.M. Case No. 1409 of 2019 titled as "*Anshul Singhal v. Harshita Goel*" pending in the Court of Principal Judge, Family Court, Muzaffarnagar (UP) to the Court of Principal Judge, Family Court, Karkardooma Court (North East District), Delhi.

Learned counsel for the petitioner submitted that the petitioner has sought transfer of the said case as she is residing at Delhi and the distance between the Family Courts at Muzaffarnagar(UP) and Delhi is over 143 Kms and it is not possible for the petitioner to travel all the way to Muzaffarnagar at UP for the purpose of defending the said case owing to financial stringency and other difficulties which are faced by the petitioner

as she is presently residing with her parents at Delhi. He submitted that in the circumstances, the petition may be allowed and a direction may be issued as prayed for in the petition. As already noted, though the respondent has been served, there is no representation on behalf of the respondent.

In the circumstances, having heard learned counsel for the petitioner and on the perusal of the material on record and having regard to the interest of justice, I find that this petition is liable to be allowed, having regard to the reasons, made out by the petitioner in the petition. Hence, the transfer petition bearing Case No. H.M. Case No. 1409 of 2019 titled as "*Anshul Singhal v. Harshita Goel*" pending in the Court of Principal Judge, Family Court Muzaffarnagar (UP) is ordered to be transferred to the Court of Principal Judge, Family Court, Karkardooma Court (North East District), Delhi.

The transfer petition is allowed and disposed of in the aforesaid terms.
