**UPON hearing the counsel the Court made the following
O R D E R**

- 1 The writ appeal before the Division Bench of the High Court of Andhra Pradesh arose from an interim order of the learned Single Judge. The Division Bench while disposing of the writ appeal has granted liberty to the appellants before it to apply for vacating the interim order with the clarification that any such application would be examined on its own merits without being influenced by the *prima facie* view taken at the time of granting the interim order. In view of the canvass which has been left open by the Division Bench, we see no reason to entertain the Special Leave Petitions against, essentially, an interim order of the Single Judge. The disposal of these petitions will not affect the direction which has been issued in paragraph 17 of the impugned judgment of the Division Bench dated 17 September 2021.
- 2 The Special Leave Petitions are accordingly disposed of.
- 3 Pending applications, if any, stand disposed of.
