O R D E R

Heard Mr. T.V. Ratnam, learned counsel appearing for the petitioners. Also heard Mr. Ananga Bhattacharyya, learned counsel appearing for respondent No. 1. Mr. Sateesh Galla, learned counsel appears for respondent No. 26. Ms. Devina Sehgal, learned counsel appears for respondent No. 27.

2. It is pointed out that the petition under Section 482 Cr.P.C. i.e. CRLP No. 1648 of 2019 is still pending before the High Court of Telangana. It is further submitted that on account of interim order passed by the High Court on 04.04.2019, all further proceedings in the Crime/FIR No. 685 of 2018 on the file of Uppal Police Station, Ranga Reddy District are stalled.

3. The indefinite stay since 04.04.2019 of the criminal proceedings may not be justified. Accordingly, the parties are relegated to argue their respective case in the pending CRLP No. 1648 of 2019. The High Court should decide the pending matter on merit without any unreasonable delay.

4. With the above order, the case stands disposed of.
