Mr. Mukul Rohatgi, learned senior counsel refers to a report submitted by the Committee constituted by the National Green Tribunal to the District Collector. According to the report no part of the land occupied by the Institutions fall within the reserve area of Soorsarovar Bird Sanctuary.

As these appeals are against an interlocutory order passed by the National Green Tribunal calling upon the opinion of Ministry of Environment, Forest and Climate Change, we are not inclined to interfere with the same.

Accordingly, the appeals are dismissed.

Pending applications stand disposed of.

The impugned order shows that the matter is listed on 22.07.2019. It is open to the appellant to raise all the grounds before the Tribunal including the question of jurisdiction before the Tribunal.
