UPON hearing the counsel the Court made the following
O R D E R

1. Learned counsel appearing for the appellants submits that the delay of 314 and 332 days caused in filing the application for substitution of the legal heirs of the deceased appellant Nos.3 and

5 is due to bona fide reasons as the legal heirs of deceased appellant Nos.3 and 5 were in painful state due to sudden demise of appellant Nos.3 and 5 and it took some time to seek necessary instructions. It is further submitted orally by the learned counsel that the learned Advocate on record was designated as Senior Advocate as such it required some time for engagement of the another counsel.

2. Accepting the submissions of learned counsel, delay is condoned.

3. Accordingly, all the applications, i.e., IA No.18749/2025, IA No.1947/2025, IA No.1951/2025 and IA No.1953/2025 are allowed.
