O R D E R

The transfer petition has been filed by the petitioner-wife seeking transfer of the divorce petition bearing no. A/642/2020 titled as "Balakrishna Sailu Jalanila Vs Nandini Balakrishna Jalanila Alias Nandini Govind Beechupalli" pending before the Court of Principal Judge, Family Court No. 1, Pune, Maharashtra to the competent family court at Kurnool, Andhra Pradesh. Nobody has filed appearance on behalf of the respondent, though duly served.

It is sought to be submitted by Learned Advocate for the petitioner Ms. K. Radha that the petitioner is housewife and the respondent is not paying any maintenance to the petitioner. One complaint filed by the petitioner is pending at the Court at Kurnool and hence, the divorce petition filed by the respondent also be transferred to the Family Court, Kurnool, Andhra Pradesh. She submitted that the father of the petitioner is a washerman and cannot afford to send the petitioner to Pune on every date of hearing.

Since nobody has appeared for the respondent, it is presumed that the respondent has no objection if the divorce proceedings are transferred as prayed for in the present petition. The petitioner has made out sufficient ground for transfer of the said

proceedings, as projected by the Learned Advocate for the petitioner.

In that view of the matter, the present petition deserves to be allowed. The Divorce proceedings being no. A/642/2020 are transferred from the Family Court at Pune, Maharashtra to the Family Court at Kurnool, Andhra Pradesh as prayed for. Hence, the transfer petition stands allowed accordingly.

Pending application(s), if any, shall stand disposed of.
