O R D E R

1. The application for listing the review petition in open Court is rejected.
2. In this petition, prayer has been made for review of order dated 04.07.2018 passed in SLP(C)No.17364/2018.
3. The petitioner has also filed an application for condonation of 338 days' delay in filing the review petition. We have perused the averments contained in the application for condonation of delay and are convinced that the explanation given by the petitioner is wholly unsatisfactory.
