**O R D E R**

This transfer petition has been filed by the petitioner-wife seeking transfer of F.C.O.P. No. 570/2020 filed by the respondent-husband under Section 9 of the Hindu Marriage Act, 1955, pending before the Family Court, Hyderabad titled "*Sirish Vijay Saxena vs. Sonal Sirish Saxena*" to the Court of Principal Judge, Family Court, Thane, Mumbai, Maharashtra.

Notice was issued on 15.02.2021 and as per the Office Report, notice has duly been delivered to the respondent-husband on 24.02.2021 with AD Card signed by his father. He has, however, not entered appearance.

The marriage between the parties was solemnized on 26.04.2007. A male child born out of the wedlock on 1.12.2011 is in the custody of the petitioner. The distance between Hyderabad and Thane, Maharashtra is stated to be more than 700 kilometres.

In fact the petitioner-wife has already filed a petition under Section 13 of the Hindu Marriage Act, 1955 seeking dissolution of marriage at Thane, Mumbai, Maharashtra.

Taking these factors into consideration, but without expressing any views on merits, the instant transfer petition is allowed and F.C.O.P. No. 570/2020 titled "*Sirish Vijay Saxena vs. Sonal Sirish Saxena*" pending before the Family Court, Hyderabad is transferred to the Court of Principal Judge, Family Court, Thane, Mumbai, Maharashtra

The records pertaining to F.C.O.P. No. 570/2020 shall be sent to the transferee Court, forthwith.

Pending applications, if any, shall stand disposed of accordingly.
