O R D E R

SLP(Cr1.) No(s).7965-7966/2021

1. We are informed that the case is now fixed at the stage of framing of charges.
2. The Trial Court is directed to decide the issue of framing of charges on the date fixed i.e., 18.08.2023, whereafter the case be listed for prosecution evidence. The prosecuting agency shall ensure that the eye-witnesses are made available at the earliest for their examination.
3. Post the matters for hearing on 06.11.2023.
4. Meanwhile, the State of Karnataka to ensure the implementation of scheme of protection of witnesses qua the complainant and other eye-witnesses.

SLP(Cr1) No.10162/2021

1. Having regard to the period already undergone by the petitioner in custody, the petitioner is directed to be released on interim bail subject to his furnishing bail bonds to the satisfaction of the Trial Court. The interim bail will be without prejudice to the rights of the State of Karnataka in this case as well as the connected matters.
