O R D E R

SLP(C) No.17186/2019

Mr. S.R. Singh, learned Senior Advocate appearing on behalf of the petitioner, seeks permission to withdraw the present special leave petition by submitting that the period of licence has expired and that the goods stored have already been removed.

In that view of the matter, the present special leave petition stands dismissed as withdrawn.

REST OF THE MATTERS

Permission to file special leave petition(s) is granted.

Delay condoned.

Leave granted.

Feeling aggrieved and dissatisfied with the impugned judgment(s) and order(s) dated 31.05.2019 passed by the High Court of Judicature at Allahabad in Writ-C No.11650 of 2019 and other allied writ petitions by which the High Court has upheld the vires of the Uttar Pradesh Minerals (Prevention of Illegal

Mining, Transportation and Storage) (First Amendment) Rules, 2019 (hereinafter referred to as 'the UP Minerals Rules 2019'), the original petitioner(s)/writ petitioners have preferred the present appeals.

Having heard learned counsel appearing on behalf of the parties and having gone through the impugned judgment(s) and order(s) passed by the High Court, we are of the opinion that as such no error has been committed by the High Court in upholding the vires of UP Minerals Rules 2019.

Learned counsel for the respective petitioners, however, have prayed for to grant them reasonable time to remove the goods/mines/minerals already stored during the licence period. They have also requested to direct the appropriate authority to grant the transit permission at the earliest so that the goods lying/stored can be removed by them within stipulated time which may be granted by this Court.

Mr. Ardhendumauli Kumar Prasad, learned Additional Advocate General appearing on behalf of the respondent-State, has submitted that as such the High Court in the impugned judgment and order has already granted them sufficient time to remove the goods already stored. However, ultimately he has left it to the Court to grant some reasonable time to the respective appellants to remove the goods already stored.

In the peculiar facts and circumstances, more particularly, when by way of an interim order, this Court has directed not to take coercive action against the appellants, because of that, the appellants might not have been able to

remove the goods stored, we are of the opinion that some reasonable time be granted to the respective appellants to remove the goods/mines/minerals already stored.

Having heard learned counsel appearing for the respective parties and as observed above, as such we see no reason to interfere with the impugned judgment(s) and order(s) passed by the High Court upholding the vires of UP Minerals Rules 2019.

However, in the peculiar facts and circumstance and to strike the balance and the fact that the issue is only with respect to the storage licence and the respective appellants were litigating before the Court, we deem it appropriate to grant further three months' time to the respective appellants who were having licences to store the respective mines/minerals.

Ordered accordingly.

We permit the concerned appellants to make the applications before the appropriate authority for removing of the goods/mines/minerals already stored during the validity period of licence, to be made within the period of two weeks' from today. On such applications, the appropriate authority shall process such applications and grant transit permission within a period of further two weeks' time. Thereafter, within a period of three months' time, the respective appellants in whose favour the licences were granted have to remove the goods stored within the period of three months from grant of such permission.

We make it clear that so far as the constitutionality of UP Minerals Rules 2019 is concerned, we uphold the impugned judgment(s) and order(s) passed by the High Court.

The appeals stand disposed of in terms of the above.

All the interlocutory applications, if any, including the applications for intervention and impleadment also stand disposed of.
