1. This transfer petition has been filed by the petitioner-wife under Section 25 of the Code of Civil Procedure, 1908 seeking transfer of H.M.A. No.273 of 2018, titled as "*Rahul Singh Vs. Shaifali Diwakar*", pending before the District Judge, Family Court at Faridabad, Haryana, to the Court at Jhansi, Uttar Pradesh.
