O R D E R

The present petition by the wife is for transfer of the case registered as M.C. No.177 of 2020 filed under Section 13(1)(i)(a) of the Hindu Marriage Act, 1955, titled as "Amarnath Shetkar Versus Smt. Chennaveeramma", pending before the Principal Judge, Family Court, Bidar, Karnataka to the Court of Family Judge, City Civil Court at Hyderabad, Telangana.

The reason for which such transfer is asked for by her is that she is at present residing with her mother and a young minor daughter, who is 3 years old at Hyderabad and she will have great difficulties in having to travel alone from Hyderabad to Bidar, Karnataka to defend the divorce proceeding brought by her husband.

Considering the fact that the petitioner-wife is staying with her mother and 3 years old daughter at Hyderabad, in my opinion, interest of justice would

be served in the event the Petition bearing M.C. No.177 of 2020 is transferred to the Court of Family Judge, City Civil Court at Hyderabad, Telangana. Ordered accordingly.

Once the records are transferred, the Presiding Judge of the Family Court, City Civil Court at Hyderabad shall allocate the case to an appropriate Bench and the proceeding after transfer is effected shall commence from the stage at which the case was pending before the Principal Judge, Family Court, Bidar, Karnataka.

Let the records be transferred forthwith to the Court of Family Judge, City Civil Court at Hyderabad, Telangana.

The present Transfer Petition stands allowed in the above terms.
