Having heard learned counsel appearing for the respective parties and considering the fact that with respect to very property, an appeal before the Debts Recovery Tribunal- II, Ahmedabad being Appeal No.9 of 2019 is pending, without expressing anything on merits in favour of either of the

parties, we simply direct Debts Recovery Tribunal- II, Ahmedabad to finally decide and dispose of Appeal No.9 of 2019 at the earliest, but not later than 31.12.2022.

It goes without saying that all the contentions and defences, which may be available to the respective parties are kept open, to be considered by Debts Recovery Tribunal- II, Ahmedabad, which may be dealt with and considered in accordance with law and on its own merits.

In the meantime, as ordered earlier, the parties are directed to maintain status quo.

With this, the Special Leave Petition stands disposed of.

In view of the above, the Contempt Petition stands disposed of.

Pending applications including the application for impleadment shall also stand disposed of.
