Delay condoned.

Permission to file contempt petition is allowed.

Applications for Impleadment/ Intervention are allowed.

The Contempt Petition No.1921/2017 and all other connected contempt petitions submitted that there was wilful refusal to follow the directions issued by this Court in its order dated 18.03.2015. The Contempt Petitions engaged the attention of this Court for some time and finally by order dated 07.09.2018 this Court categorically observed that no contempt was made out. The contempt petitions thus stood disposed of.

However, by the very same order dated 07.09.2018 this Court had made following observations:

"Faced with such a situation, we are of the view that the CGIT, New Delhi should look into the matter with regard to the claims made by the Union(s)/individual workmen, regarding entitlement to the benefits under the Award and submit a report to this Court. Accordingly, we direct the CGIT, New Delhi to look into the claims made by the Union(s)individual workmen and submit a report to this Court within three months."

The CGIT shall, therefore, in terms of the direction, look into the matter with regard to the claims made by Union(s)individual workmen.

It appears that the matters are still pending with CGIT

and a prayer for additional time has been made. We accede to the request and direct the CGIT to complete the entire process within four months from today and submit the report as contemplated by order dated 07.09.2018 (As clarified by later order dated 10.09.2018). The matter shall now be listed only for consideration of the report.

All the matters stand disposed of. After the report is filed, the Registry shall give copies to concerned parties, on request.

Pending applications, if any, also stand disposed of.
