Heard Mr. Sanjay Jain, Additional Solicitor General for
the petitioner and Mr. Maninder Singh, learned senior counsel for
the Respondents.

These Special Leave Petitions have been filed against the
interim order dated 22.09.2020 passed in W.P.(C) No. 6756/2020 and
order dated 09.10.2020 in LPA No. 267/2020 by which order on the

request of the counsel for the appellant i.e. Petitioner, matter is listed on 27.11.2020. Shri Jain submits that there is an urgent requirement of hearing the matter since situation in Delhi regarding necessity of providing ICU beds to Covid-19 patients is increasing day by day.

Shri Maninder Singh submits that the matter is listed before the Single Bench on 18.11.2020 and insofar as LPA is concerned, he has no objection if the matter is taken up on any early date by the Division Bench.

In view of the above, we are of the view that looking to the facts of the case and the request made by learned counsel for the parties, we request the concerned Bench for taking up the LPA on 12.11.2020.
