UPON hearing the counsel the Court made the following
O R D E R

Having heard the learned senior counsel appearing for the petitioner-husband and learned counsel appearing for the respondent-wife, in the facts and circumstances of the present

case, especially, keeping in mind that there is a child born to them and also that they have not been living together since the year 2009; on the parties request, the matter is referred to the Mediation Committee of the Jharkhand High Court at Ranchi.

2. Initially, the parties shall appear physically before the Mediation Committee on 02.04.2025 at 02:30 p.m. The Jharkhand High Court Mediation Committee is requested to entrust the matter to a senior and experienced Mediator. It is made clear that the parties would be free to discuss each and every issue and all aspects for a full and final settlement between them amicably.

3. The learned Mediator is requested to submit a report within a period of two months.

4. In the meantime, all pending proceedings *inter se* between the parties shall remain stayed.

5. The petitioner-husband shall transfer a further amount of Rs.5,00,000/- (Rupees Five Lakhs) in the account of respondent-wife within two weeks from today.

6. List the matter on 23.07.2025.
