**UPON hearing the counsel the Court made the following
O R D E R**

The Court is convened through Video Conferencing.

The application for exemption from filing affidavit is allowed.

Taking into consideration the fact that the complainant and all the accused belonged to the same family and the dispute between them related to family properties, vide order dated 15.12.2020, on the consent of the parties, we referred the dispute to Hon'ble Mr. Justice S.J. Vazifdar, former Chief Justice of the Punjab and Haryana High Court to resolve the dispute between the parties. In compliance of the said order, Mediation Report was sent by the learned Mediator.

Vide order dated 19.02.2021, the parties were again directed to approach Hon'ble Mr. Justice S.J. Vazifdar, former Chief Justice of the Punjab and Haryana High Court to try for settlement of the dispute in question.

Today, during the course of hearing, it has been brought to our notice that the matter has been settled between the parties and a Mediation Report in a sealed cover has been filed.

In view of the Settlement Agreement arrived at between the parties, the interim protection granted to the petitioners herein is made absolute.

The parties are directed to abide by the terms of Settlement Agreement in its letter and spirit.

The special leave petitions stand disposed of in terms of the Settlement Agreement arrived at between the parties.

As a sequel to the above, pending interlocutory applications also stand disposed of.
