None has appeared on behalf of the respondent. At the last date of hearing also none had appeared.

It may be noted that, by the order dated 26.12.2020 issuing notice, proceedings in H.M.O.P. No. 88 of 2020 titled "Budehal Kiran Kumar v. B. Priyanka", pending before the Court of the Additional Senior Civil Judge, Anantapuramu, Andhra Pradesh were stayed. It is, therefore, apparent that the respondent is aware of the pendency of the present transfer petition.

The respondent is, accordingly, proceeded *ex parte*.

In view of the averments made in the transfer petition and in the interest of justice, the transfer petition is allowed.

Accordingly, H.M.O.P. No. 88 of 2020 titled " Budehal Kiran Kumar Vs. B. Priyanka, pending before the Additional Senior Civil Judge, Anantapuramu, Andhra Pradesh is transferred to the Court of competent jurisdiction in the District Courts, Bengaluru, Karnataka.

Records of the case would be immediately transferred to the transferee court, which may hear the case or assign it to a competent court having jurisdiction.

To cut short delay, parties are directed to appear in-person or through the authorized representatives, before the transferee court on 12.10.2022. In case there is non-appearance on behalf of the party on the date fixed, court notice would be issued by the transferee court.

The parties may explore the possibility of settlement through mediation. The transferee court would obtain the desire and wishes of the parties and proceed accordingly in this regard.

Pending application(s), if any, stand disposed of.
