When the matter came up for hearing before this Court, we sought the assistance of Ms. Shobha, learned Advocate as Mediator. We are informed that learned Mediator has conducted several sessions with the parties. Unfortunately, they are not able to agree either way, as of now. Therefore, we do not see any point in continuing this case any further before this Court. All such efforts should be now left to the Family Courts concerned.

In the peculiar facts and circumstances of the case, we are of the view that it will be in the interest of both the parties to have the case transferred to and disposed of by the Family Court, Hisar.

Accordingly, we deem it fit and proper to transfer the Petition No. 1/2016 titled "Sunil Kumar Vs. Ankita Chahar" pending before the Court of Additional District and Sessions Judge, Rajgarh, District Churu, Rajasthan to Family Court at Hisar. Ordered accordingly.

By order dated 14.11.2017, this Court had stayed the pending cases and the order on maintenance. Since the

attempts for Mediation have failed, the order dated
14.11.2017 stands recalled.
