**UPON hearing the counsel the Court made the following
O R D E R**

- 1 Mr Vikram Choudhary, learned senior counsel appearing on behalf of the applicant states that the applicant has since the previous order dated 20 November 2020 tested **negative** for Covid - 19. Learned senior counsel states that the applicant would surrender to sentence by 3 December 2020.
- 2 By the order of this Court dated 20 November 2020, having regard to the then Covid-19 status of the petitioner, time to surrender was extended until 3 December 2020. Since the petitioner is no longer Covid positive and in terms of the order of this Court dated 5 November 2020, he shall first surrender and then renew his application before the Uttarakhand High Court for suspension of sentence.
- 3 Before the High Court takes up the proceedings on 4 December 2020, it shall ensure compliance with the present order and the application for suspension of sentence shall be taken up on production of proof that the petitioner has surrendered to the sentence.
- 4 The Miscellaneous Application is disposed of.
