1. This petition is filed under Section 25 of the Code of Civil Procedure seeking transfer of Marriage Petition No.979/2023 titled "*Durgesh Choudhary vs. Jaya Durgesh Choudhary*", pending before the Court of Ld. 13th Joint C.J.S.D. and Additional C.J.M, Pune City, Pune to the Court of Ld. Principal Judge, Family Court, Delhi.

2. Despite service of notice, no one has entered appearance on behalf of the respondent.

3. The grounds raised by the petitioner for seeking the transfer are that she has to take care of her minor child; and also on account of long distance she is unable to effectively defend the proceedings at Pune.

4. On such consideration, we are of the view that the transfer can be allowed. Consequently, the Transfer Petition is allowed.

5. Accordingly, Marriage Petition No.979/2023 titled "*Durgesh Choudhary vs. Jaya Durgesh Choudhary*", pending before the Court of Ld. 13th Joint C.J.S.D. and Additional C.J.M, Pune City, Pune is transferred to the Court of Ld. Principal Judge, Family Court, Delhi.

6. The transferor Court shall forward the records pertaining to the said case to the transferee Court, as expeditiously as possible.

7. Parties are directed to appear before the concerned Court on 17th November, 2025.

8. The Respondent-husband is permitted to attend the proceedings virtually, unless his presence is required by the trial Court.

9. Pending application(s), if any, shall stand disposed of.
