**O R D E R**

- 1 This transfer petition has been filed by the petitioner-wife for transfer of Marriage Petition No 1697 of 2019 titled "Atul Gupta vs Swati Gupta & Anr" from the Court of the Civil Judge, Senior Division at Pune, Maharashtra to the Distirct Court, Agra, Uttar Pradesh.
- 2 We have heard counsel appearing on behalf of the parties.
- 3 Having regard to the interests of justice, we are of the view that an order for the transfer of the proceedings is warranted. We accordingly allow the transfer petition and direct that Marriage Petition No 1697 of 2019 titled "Atul Gupta vs Swati Gupta & Anr" be transferred from the Court of the Civil Judge, Senior Division at Pune, Maharashtra to the Distirct Court, Agra, Uttar Pradesh.
- 4 The transferor court shall forthwith transmit the record of the aforesaid case to the transferee court.

- 5 Counsel appearing on behalf of the respondent-husband states that the respondent may be permitted to attend the proceedings in the transferee court through a virtual platform.
- 6 The transferee court shall consider the request of the respondent for attending the proceedings through video conferencing.
- 7 After transfer of the petition, the transferee Court is directed to make all endeavour either for amicable settlement or for early decision in the matter without unnecessary adjournments.
- 8 Pending application(s), if any, stands disposed of.
