Having heard learned counsel for the parties and considering the facts of this case, we do not find any ground to

interfere with the order passed by the High Court. The Special Leave Petitions are, accordingly, dismissed.

However, considering the fact that the petitioner has been in occupation of the premises for a reasonable long period and will take some time to vacate the premises, we direct that in case the petitioner deposits the entire decretal amount along with future occupation charges up to 28.02.2022 within three weeks from today and gives usual undertaking to vacate the premises by 28.02.2022 within a period of three weeks from today, the petitioner shall not be evicted from the premises in question till 28.02.2022.
