O R D E R

This petition has been filed by the petitioner (wife) under Section 25 of the Code of Civil Procedure, 1908 seeking transfer of the H.M.O.P. bearing No.7 of 2019 titled as Lt. Cdr. N. Kattaboomman vs. Maya Bhargavan pending before the Family Court, Udumalpet Tiruppur District, Tamil Nadu to a court of competent and equivalent jurisdiction at Ernakulam, Kerala.

Heard Ms. Lakshmi N. Kaimal, learned counsel for the petitioner. Also heard Mr. M.P. Parthiban, learned counsel appearing for the respondent (husband).
